The University has not made a determination on the existence of a component unit. The selected audit firm will be responsible for the determination of what qualifies as a component unit as defined by GASB. Please note that the selected firm will not be expected to provide audit services to any component unit as a part of this RFP.

Subsequent to the disassociation w/ the foundation, the University estimates the following amounts related to donor giving in FY19 collected by the University:

• Pledges for contributions made: \$26,835
