Lincoln University Board of Curators April 15, 2021 OPEN SESSION

1. Call To Order:

The Lincoln University Board of Curators Open Session was officially called to order by Board President Victor B. Pasley at 9:00 a.m., on Thursday, April 15, 2021, in the Board Room, 201 Young Hall, on the Lincoln University campus, Jefferson City, Missouri. Due to the COVID-19 pandemic, the Board meeting was held in person and via zoom.

- 1. A. Roll Call: Curators present were: Vernon V. Bracy, Stacia R. Bradley Brown, Everidge Cade, Jr., Richard G. Callahan, Don W. Cook, Sr., Frank J. Logan, Sr., Victor B. Pasley, Richard R. Popp, and Terry Rackers. Rose Ann Ortmeyer recorded the minutes.
- 2. Approval of the Open Session Agenda (Action Enclosure 1):
 Curator Cook moved for approval of the Open Session Agenda as distributed. Curator Callahan seconded the motion. Motion carried.
- 3. Approval of the February 4, 2021 and Marsh 23, 2021 Open Session Minutes (Action Enclosure 2):

Curator Popp moved for approval of the February 4, 2021 and March 23, 2021 Open Session Minutes. Curator Rackers seconded the motion. Motion carried.

4. Report from the President of the Lincoln University Board of Curators - Victor B. Pasley:

Board President Pasley welcomed the the three newest Curators, Dr. Stacia Bradley Brown, Richard G. Callahan, and Terry Rackers and asked each of them to introduce themselves and share their backgrounds.

Board President Pasley stated that the Board will hold a retreat leading up to the September Board meeting. (Possibly September 7 & 8.) The Executive Committee of the Board will set the retreat agenda.

Representative Dave Griffith, on behalf of the Missouri State Senate and the Missouri House of Representatives, read a proclamation commemorating the Centennial of the 1921 passage of HB 539, introduced by Walthall M. Moore, the first African American to be elected to the Missouri Legislature, designating Lincoln Institute as Lincoln University. Mayor Carrie Tergin, also read a proclamation from the City of Jefferson.

4. B. Explore Relationship with the Foundation:

The Committee shall consist of Victor Pasley, President of the Board, who would chair the Committee. The Committee shall also include the President of the University, Dr. Woolfolk, and two additional Board members to be named by the Board President. The Committee shall be given authority to explore a reaffiliation, and, if considered advisable, develop an agreement between Lincoln University and the former Lincoln University Foundation, Inc. acceptable to both organizations for consideration and approval by the Board of Curators. Action Item: Blue Tiger Academy tuition rate

Blue Tiger Academy is an exciting summer academic program that serves a diverse undergraduate community entering Lincoln University. The program introduces students to the college's structure, the rigor provides opportunities to foster meaningful academic and social connections and empowers students to take ownership of their educational journey. Each student must enroll in a minimum of twelve credit hours, meet weekly with their peer mentor, peer tutor, and SI leader for guidance on the road to academic success. Students will be assigned a Faculty Advisor and a Student Success Team member to assist with a successful transition to Lincoln University.

It is important to ensure that all students who opt to participate in the Blue Tiger Academy are not deterred by cost. For this reason, the University is recommending that the cost of the Blue Tiger Academy be set to equal the maximum Pell award for a summer semester and will not exceed the hourly rate of in-state undergraduate tuition as established by the Lincoln University Board of Curators. Maximum Pell awards are established by the US Department of Education. This cost would cover tuition, fees, room and board as applicable.

Below is an example of the cost of the Blue Tiger Academy (BTA) program. Pell (summer) for 2018-2019 was \$3,048. Pell (summer) for 2020-2021 is \$3,173.
