# Lincoln University Vision: A 21<sup>st</sup> Century HBCU

For those students who come to us in need of an institution that provides opportunity when others do not, the university opens minds to new ways of learning through exposure not only to caring faculty and staff, but also to peers who serve as leaders along their academic journey.

Academically, the university offers education that will best serve the future workforce. A Lincoln University education has transformed the lives of generations of students. As a 21<sup>st</sup> century institution of higher education, Lincoln utilizes technology to meet students where they are to help them achieve their dreams through multiple methods of engagement including traditional classroom, online, credit for life experiences, intern and work experiences. #### Heart of Missouri Scholarship Criteria

Recipients of the Heart of Missouri Scholarship must meet the following criteria:

- A high school graduate of an accredited high school in the following counties: Cole, Boone, Howard, Cooper, Morgan, Miller, Maries, Osage, Callaway, Moniteau.
- Must currently reside in one of the following counties: Cole, Boone, Howard, Cooper, Morgan, Miller, Maries, Osage, Callaway, Moniteau.
- Must matriculate directly from high school. If a student opts to start in the summer prior to
  their first fall semester, they are still eligible for the scholarship in the fall. If a student opts to
  sit out for the fall semester and begin in the spring, they are not eligible for the scholarship.
- Must earn an 18 or greater on the ACT test.
- Must earn a cumulative high school GPA of 3.0 or greater on a 4.0 scale on the final high school transcript.
- Awards are contingent on the final high school transcript information.
- Recipients must be a degree seeking student.
- Scholarship recipients must be enrolled as a full time student (12 hours or greater).
- Student must successfully complete a minimum of 24 credit hours each academic year.
- Scholarship recipients will receive \$1,000 per semester (fall and spring) for up to 8 consecutive semesters.
- Scholarship is not available for the summer semester.
- Recipients cannot receive the Curators, Presidential, Institutional, Dean's or LUA+ in conjunction
  with the Heart of Missouri Scholarship. Students must select which scholarship best fits their
  needs.
- Students are not required to apply for the FAFSA.
- Recipients must maintain a cumulative GPA of 3.0 to retain the scholarship.
- If a student fails to meet the criteria, the scholarship is permanently lost.
- Funds are not refundable.
