Action Item - Proposed change to Rules & Regulations Section 5.34

Overview: The Division of Student Affairs requests a revision to the Lincoln University Rules and Regulations regarding the on-campus housing policy (Chapter V: Section 5.34, pp. V-7 & V-8). The proposal is for adding clarifying language to the on-campus housing policy related to graduating seniors and students with less than twelve (12) credit hours for the 16-week semester but are enrolled full-time for the first or second 8-week terms collectively.

Current Policy:

5.34 On-Campus Housing Policy

The educational value of campus residence living has long been established. To this effect, the area of Student Affairs administers an on-campus housing policy. Following are the rules and regulations of this policy:

- All entering unmarried freshmen under twenty-one years of age, officially registered for twelve or more academic hours and whose primary domicile is beyond a sixty-mile radius of the university, are required to reside in the campus residence halls for four consecutive semesters.
- Room and board are mutually inclusive components of on-campus residency.
- All unmarried international students under the age of twenty-one are required to reside on campus for four consecutive semesters. Room and board are mutually inclusive components of their contracts.
- 4. Students who desire an exemption from this policy must file a written request to the Residential Life Appeals Board.
- 5. Veterans of the U.S. Armed Forces are exempted from this policy.
- Transfer students under twenty-one years of age with verification that they resided for a
 minimum of two semesters in on-campus housing at another institution are exempted from
 this policy.

- 7. All unmarried transfer students under twenty-one years of age, whose primary domicile is beyond a sixty-mile radius of the university, who have lived in on-campus housing for less than two semesters are required to live on campus for the remainder of the four semester duration; e.g., students who lived on campus at another institution for one semester are required to live for three semesters in a Lincoln University residence hall.
- 8. Students whose twenty-first birthday occurs while living in a residence hall are required to remain in the residence hall until the end of that semester. At that time, the Buy-out Policy may apply. (See section 4.34.1.)
- 9. In the event rooms on campus are not available to accommodate all students affected by the On-Campus Housing Policy, a waiting list will be maintained. Those students on the waiting list will be furnished with a list of off-campus realtors. Those students will be responsible for their own housing that semester. In the event that the lease for off-campus housing is a twelve-month lease, students will be expected to fulfill the requirements of Lincoln University and spend two concurrent semesters on campus. Students on the waiting list will be notified the following semester when space is available for them to move on campus.
- 10. Each student living off campus, due to unavailable space, must report to the Office of Student Life with their current address and phone number. These students will be notified by mail of their room assignment on campus for the following semester/year.

Notification of housing assignments will be sent to students' local addresses prior to the end of the spring semester of the initial year at the university. Registration for the next academic year will automatically include room and board costs.

Notwithstanding the university's strong commitment to the student development philosophy, the official residence hall contract explicitly states the mutual rights and responsibilities of the university and its residential students. In the spirit and intent of the University Oath, it is the position of the university that on-campus living is a privilege, not an obligation, for students. Consequently, the university reserves the exclusive right to negotiate and/or terminate contractual arrangements between its students at any time it deems appropriate.

Proposal:

- Graduating seniors needing less than twelve (12) academic hours may reside on campus with verification from their academic advisor. Verification must be submitted through the Residence Life Review Board.
- 2. When officially registered for twelve (12) or more academic hours per semester, students may reside on campus, which includes a combination of 16-week and both 8-week terms.
- Changing the name of the 'Residence Life Appeal Board' to the 'Residence Life Review Committee.'

Rationale:

- 1. Some graduating seniors only need a few classes in either the fall or spring semester but are not financially able to reside off-campus locally.
 - a. Adding the clarifying language includes said students and offers an opportunity to eliminate creating any undue financial hardship.
 - b. Additionally, like education majors, some students only need a few credit hours in the fall semester during student teaching in the spring.
- 2. Students officially registered for twelve (12) academic hours, including the 16-week semester and the first or second 8-week terms.
 - a. Students who register for classes a week before the semester begins are often left with few class options. This is significant for new first-time students and returning students who are late. Including the three (3) terms collectively will allow students to reside on campus, as long as their total enrollment calculates to full-time status (12 credit hours).
 - b. The current policy only makes this distinction for new first-time students and not all students. The included language, or modified language, will include all students, regardless of classification.
- 3. Changing the 'Residence Life Appeal Board' to the 'Residence Life Review Committee' will broaden the scope of the unique cases presented for consideration.
 - a. The language of an "appeal board" suggests that there has been a violation of university policy providing cause for an appeal of a student's housing situation. Broadening the panel's scope to a "review committee" allows for a review of all unique cases, including those of a positive nature.
