### LU / LIR Parking Permits

Lincoln University parking permits for LIR members will be available at the membership meeting on January 17<sup>th</sup>, or during regular hours at the LIR Office. Parking permits are good only for parking on the Soldiers Hall lot. Permits are valid from September 1, 2017, through August 31, 2018.

To obtain the permit, you need the following information: vehicle make, model, color, license plate number, and your drivers' license number. Cost of the permit is \$10.

### Payment Procedure Trips, Courses, Dues and Events

To streamline the payment process for trips, courses, and membership dues, the following payment procedure is recommended for efficient recording and processing.

**TRIPS** – A separate check should be issued for trips. Trips may be combined on one check, or a separate check for each trip may be submitted if that is your preference. Couples may combine payments on one check. Be sure to attach check(s), with trips noted, to the Trip Registration Form found in this newsletter.

**COURSES** – A separate check can be issued for one or all of the courses that an individual wants to attend. Please note which course(s) are being paid. The Membership Meeting and Course Registration Form is included in this newsletter.

**MEMBER APPLICATION/DUES** - A separate check should be issued for membership dues. A Membership Application form is included in this newsletter.

# Info B4 You Go:

- On our trips, we visit both public- and governmentsponsored sites. It is the responsibility of the traveler to follow the guidelines as dictated by the venues we visit.
- All LIR travel via coaches depart and return to Wal-Mart Super Center, 724 W. Stadium Blvd. (near the Central Bank ATM). Coaches most often arrive 30 minutes prior to departure time.
- Gratuities: Gratuities (tips) are covered for the coach driver, for all included meals, and for step-on guides. Hotel house-keeping tips are at your discretion. Donations are included for charitable venues.
- Comfort stops are planned anytime the travel time is between 2 and 2 1/2 hours. Passengers are encouraged to leave the coach for a short walk for their health.
- Water is provided for the passengers on all coach trips. Take advantage of it.
- If special dietary needs are required, you should call the LIR office to express that special accommodation.
- Wear your name badge on every trip. For your safety, care should be taken to remove or cover name badges when walking on streets in major cities.
- If you are registering with a friend for trips, we strongly encourage you to mail or drop off registrations together. Each registration is recorded as received.

# TRIPS: JANUARY - JUNE 2018

#### Crystal Bridges and Everything Bentonville, AR

Wednesday-Friday, April 4-6, 2018

Join us for a fun-filled three-day trip to experience all Bentonville, Arkansas has to offer. This small town located in northwest Arkansas has bloomed with the headquarters of Wal-Mart being its driving force. We will take a short comfort break at a Wal-Mart in Springfield, Missouri, in case you forgot to pack something, before arriving in Bentonville in time for lunch.

Our first stop upon arriving in Bentonville will be the beautiful Crystal Bridges Museum of American Art, including the Bachman-Wilson house designed by Frank Lloyd Wright in 1954, now located on the Crystal Bridges Museum grounds. Lunch will be on your own at the Eleven Restaurant located inside the Museum.



In the afternoon, we will tour the iconic Italianate Victorian Peel Mansion built in 1875 by Colonel Samuel Peel. Dinner will be at Fred's Hickory Inn, a Bentonville staple since 1970.

We will be spending two nights at the Holiday Inn Express in Bentonville where we will be treated to a complimentary buffet breakfast each morning.

Day Two begins with a tour of the Walton Museum, the birthplace of Wal-Mart, located on the town square. Walton's 5 & 10 is a real, working store chock full of retro toys, candies, and souvenirs. Following the tour, travelers will have time to explore Bentonville's beautiful town square, enjoying the small shops and choosing one of the many restaurants on the square for lunch on your own.

After lunch, we will tour the Native American History Museum. The exhibits are arranged in chronological order, starting with the early Paleo through the historic periods. The museum contains one of the largest and most diverse displays of stone tools, arrowheads, and pottery.

We will tour the new addition to the Bentonville tour scene: The Brightwater Culinary. Its goal is to develop leaders who combine culinary skills with the ability to recognize and address complex food issues focusing on nutrition while reducing waste. Dinner on

Thursday night will be at Joe's Italian Grill located just off the town square.

Our first stop on Friday morning is for a moment of peace and serenity at the Mildred B. Cooper Chapel in Bella Vista. The Chapel, with glass walls and a ceiling standing 48 feet high, reaches out to nature with oak and pine forests framing the view.



Afterwards, we will board the coach for home, stopping at Sandstone Gardens at Joplin, Missouri, for an early lunch at Sandstone's Bistro. Time will be available for a bit of shopping for garden and home amenities. The afternoon will find us continuing our journey home.

All admissions and gratuities, plus dinners at Fred's Hickory Inn, Joe's Italian Grill, and lunch at Sandstone Gardens' Bistro, are included in the trip cost. Arrangements can be made at each of these restaurants to accommodate special dietary needs. Breakfasts are complimentary at the hotel. Lunches at Crystal Bridges and the town square are on your own.

#### Pella, Iowa, Tulip Festival, and Amana Colonies

Wednesday, Thursday, and Friday, May 2, 3, & 4, 2018

Tiptoe through the tulips with LIR as we travel to Pella, Iowa, for the annual Tulip Festival. Arriving in Pella, we will have a buffet lunch at Monarchs featuring Dutch food. A step-on guide will join us for a tour of the town after lunch.

We will spend the rest of the afternoon touring the Historical Village and Vermeer Mill. You will have time to explore the town on your own before heading to the Best Western Holiday Manor in Newton, Iowa. Dinner is on your own at Hy-Vee.

Our first stop will be the Harry S Truman Presidential Library and Museum where we will be treated to a docent-led tour giving us insight into his public and private sides. We'll learn (or refresh our memories) of his very important decisions, their long-term significance, and how they continue to affect our lives today.

Then we head to the Bingham-Waggoner Estate in downtown Independence for a tour of the former home of George Caleb Bingham (classic artist of the early American West) and later the Waggoner family. Lunch is in their former carriage house (air conditioned!!) where a Truman impersonator will give us another view of Harry while we eat.

After lunch, we will hop (!) onto some Missouri muledrawn covered wagons for a tour of "1845" Independence. Our wagon driver will delight us with tales of Independence before Truman's time, as well as some highlights from when Harry lived there. He will drop us off at the National Frontier Trails Museum, which focuses on the challenges and excitement faced by pioneers in the 1800s. #### ST. FRANCIS, HILDEGARD, AND THE POPE INSPIRATION FOR CHRISTIANS TODAY

This 1974 British mystery film is based on the 1934 novel of the same name by Agatha Christie. She sets out to find the real killer and gets help from a congressional advisor, Eddie Sanger, who is called to be on the jury panel. Together they discover a dangerous circle of corruption in high places. This is a 1987 American mystery/ courtroom drama film starring Cher, Dennis Quaid, and Liam Neeson.

#### EXPLORING TOPICS IN ARCHEOLOGY

Time: 1:30-3:30 pm

Dates: Thursdays, March 8, 15, 22, 29, 2018 Place: The LINC, 1299 Lafayette St

March 8: Prehistoric Responses to Sudden Climate Change: We will review historical and archeological evidence for sudden climate change in the summer of A.D.1258 following the Samalas volcano eruption. Crop failure, famine, political unrest, and religious fanaticism occurred in Europe and Japan while mass migrations began in the American Southwest. Cultural responses by Native American populations in Eastern North America to a "year without a summer" in A.D. 1258 will also be reviewed.

March 15: Bioarcheology. LU Assistant Professor of Anthropology & Sociology Dr. Christine Boston will focus on the study of mummified or skeletal human remains in archeological contexts. Participants will learn about bioarcheological methods (e.g. aging and sexing, pathological conditions, biocultural conditions, etc.), as well as their applications in forensic studies. Several bioarcheological studies will also be surveyed to demonstrate the application and utility of this subject to archaeological understandings of the past.

March 22, 29. St Louis on the Frontier:

A Preliminary Analysis of a French Trading Center *AND* Archeology of the Gilded Age: MoDot archeologists are currently in the midst of a multiyear excavation of perhaps the oldest part of St Louis, located below the Poplar Street Bridge and south of the Gateway Arch. Through careful excavation, archeologists have uncovered remains of six colonial French properties, including most recently a 1760s house built by a fur trader and later used by a blacksmith. Archeological research, however, has not been restricted to the colonial period but also

includes detailed studies of roughly 60 additional properties dating from the early nineteenth century through the 1930s. Information gathered over the past decade has enhanced and, in some cases, altered our understanding of the history of St. Louis and of the region in general.
