### Welcome to 2019

We are on track to have another great year full of learning experiences that fulfill our directive set out in 1990: To have an organization of learners that are dedicated to meeting the educational interests of its members connecting Lincoln University to the community. Since our first official organization of 65 members in 1992, we have grown to 429 members. From an initial offering of six courses and two trips, we have about 20 courses and 20 trips each year. Our clubs have grown from zero to 14.

Our Educational Travel Committee has done a fantastic job in planning interesting trips. The cost of travel to you is based on what the trip costs LIR. Consequently, we have some of the most inexpensive trips offered in the Jefferson City area. Some upcoming trips include *Buddy: The Buddy Holly Story* at the New Theatre in Overland Park, Kansas; the Glenn Miller Festival in Clarinda, Iowa; Exploring French Heritage of St. Louis in the St. Louis area; and the *Million Dollar Quartet* at Shikles in Jefferson City; *Murder for Two* at the Lyceum Theater; and *Come from Away* at the FOX in St. Louis.

Our Curriculum Committee works hard to provide excellent free and low-cost courses. Some examples include \$12 courses on "Christianity in Context" and "Cole County Veterans from Four Wars." Free courses include "ABC's of Fly Tying and Fishing" and "Alzheimer's and Dementia: Loss of Cognitive Ability."

Our 14 clubs offer a wide variety of activities from walking/hiking to dominoes to bridge to music appreciation. A list of clubs and club coordinators is in this newsletter as well.

If you are interested in getting more involved in LIR, please contact me or any board member. We can always use more volunteers. If you want to join one of our clubs, please contact the club coordinator.

I hope this new year will be great for you. I know it will be great for LIR.

### **Cancellations – Inclement Weather Policy**

LIR membership meetings, classes, and clubs may be cancelled due to inclement weather if the Jefferson City Public Schools are not in session (weather related). Local radio and television stations that allow community cancellations will be notified along with one or more of the following: the LIR website, an "ALERT" group email to members, and/ or a call tree. Travel cancellations occur ONLY when the contracted coach company cancels due to its determination of highway safety. Travelers are contacted individually if a cancellation occurs.

The winter (January) general membership meeting is scheduled with a make-up date, typically the same day/time/location in the following week. Length and content of this meeting will be adjusted to accommodate the make-up situation. Should a second weather-related cancellation occur for the membership meeting, a business meeting ONLY will be held within one week of the cancelled meeting. The place and time of this meeting will be determined.

## Payment Procedure Trips, Courses, Dues and Events

To streamline the payment process for trips, courses, membership dues, and catered luncheon fees, the following payment procedure is recommended for efficient recording and processing.

• TRIPS: A separate check should be issued for each trip, if possible. Couples may combine payments on one check. Be sure to attach check(s), with trips noted, to the <u>Trip Registration Form</u> found in this newsletter.

• COURSES: A separate check can be issued for one or all of the courses that an individual wants to attend. Please note what course(s) are being paid. The <u>Membership Meeting and Course Registration</u> <u>Form</u> is included in this newsletter.

• NEW MEMBER APPLICATION/DUES: A separate check should be issued for membership dues. A <u>Membership Application</u> form is included in this newsletter.

# **Travel Trip Reminders**

LIR trips visit both public and government sponsored sites. It is the responsibility of the traveler to follow the guidelines as dictated by the venues visited.

LIR trips travel via coaches departing and returning to Walmart Super

Center, 724 W. Stadium Blvd. (near the Central Bank ATM). Coaches most often arrive 30 minutes prior to departure time.

LIR travel requires walking and the physical capability to tour the site. If you have concerns regarding the described activities, please call an escort to discuss the degree of difficulty of the trip's venues.

Gratuities (tips) for the coach driver, for all included meals, step-on guides and donations for charitable venues are covered by the cost of the trip. Meals on your own and hotel housekeeping tips are at your discretion.

Comfort stops are planned for the comfort and

well- being of travelers anytime the trip time is between 2 and 2-1/2 hours. Passengers are encouraged to leave the coach for a short walk for their health.

Water is provided for travelers on all coach trips. Take advantage of it.



Travelers with special dietary needs should contact **an escort prior to the trip** to express their required dietary accommodation.



Travelers are requested to wear their name badges on every trip. For safety, badges should be removed when walking in major cities.



Checks for multiple trips will be deposited even



when placed on a wait list for some trips. Refunds will be made after the date of the trip.

When registering with a friend for trips, you are strongly encouraged to mail or drop off

registrations together as registrations are recorded as received.



- Refunds for trip cancellations depend on the ability to fill the vacancy and/or the recovery of expenses already paid.
- NO deposit is necessary to be placed on a wait list.
- Registrants for a trip are automatically added to a wait list if the maximum number of travelers has already been confirmed.

All About Power Callaway County Tuesday, March 5, 2019

We are "charged" up to explore two of Callaway County's energy producers: Callaway Electric Cooperative and the Callaway Nuclear Power Plant with a "power" lunch sandwiched in between at downtown Fulton's unique Beks restaurant.

Callaway County Electric Cooperative provides service to about 13,000 residential, agricultural, and commercial members in rural areas and has been around since 1936. Learn about how a co-op works and all the different programs they offer for their members such as Callabyte (bringing fiber-to-thehome broadband), energy audits, teacher education and disaster cooperation. We'll tour the modern facility and learn how linemen are trained and the inside scoop on what they do.

Then, we'll head to Beks restaurant, located in the historic Fulton Brick District. You'll get to choose from 5-6 entrees (cost is included in trip price). There may be time to browse the fun stores along Court Street before we head to our next stop.

The Callaway County Nuclear Power Plant, located on 2,727 acres near Fulton, is Missouri's only nuclear facility and has been operating since December 19, 1984. The plant employs nearly 750 people and produces 20 percent of the electricity for Ameren Missouri customers. According to one report, when combining its 34-year record and its competitive rates, this plant ranks as one of the best of 99 nationally.

**PLEASE NOTE:** The Nuclear Power Plant tour will require extensive walking with stairs (no elevators) and some open grating. Some areas will be hot; other areas may be cold. There will be a security clearance form that everyone will have to fill out, which includes your social security number. We'll have more details on completing that form when you are officially registered for the trip. On the day of the tour, you will be asked to show a government issued photo ID. No pictures are allowed in the plant, so you will need to leave your phones/cameras on the secure bus.

### Glenn Miller Festival, Clarinda, IA

Let's Enjoy *In the Mood* Friday-Sunday, June 7-9, 2019

Join us for a fun-filled three-day trip to experience the wonderful world of big-band music at the 44<sup>th</sup> Annual Glenn Miller Festival in Clarinda, Iowa, Miller's hometown. Visitors and entertainers from around the world will converge in Clarinda to celebrate the music and memory of the great American bandleader, trombonist, composer, and arranger.

Getting off the beaten path of I-70, we will travel north on Highway 63 taking a comfort break at McDonald's in Macon, followed by lunch in St. Joseph. Upon arriving in Clarinda, we will check into the Boulders Inn & Suites for our two-night stay. After freshening up after our day of travel, we are off to dinner at J. Bruner's, followed by an evening concert by the world-famous Glenn Miller Orchestra. We are sure to be treated to many of his great hits, including his world-famous *In the Mood*!



Following a complimentary breakfast at the hotel Saturday morning, our step-on guide will join us, sharing the history of Clarinda and Mr. Miller. We will tour the Glenn Miller Museum and his childhood home, learning about the community and Mr. Miller's early life. Next, we will take a 20-30 minute drive through a 20-block area that features 14 historic buildings. Lunch will be at Garrison's Coffee House in charming downtown Clarinda, followed by a bit of shopping time (always a highlight!) in the quaint shops located on the Downtown Square. Then we are off to the Nodaway Valley Historical Museum, where we will view a historical quilt collection, an extensive collection of Native American relics, and seven historically preserved buildings from the Nodaway Valley region, all the while learning interesting tidbits of information from our step-on guide.

Next, we return to the hotel to freshen up before an evening of enjoyment at the Festival's Banquet and Concert, where we can dance to the music of the World-Famous Glenn Miller Orchestra. The evening includes a swing-dance competition, so be sure to pack your dancing shoes! For those of you with two left feet, we have planned staggered rides back to the hotel – one following dinner shortly after the dance begins and one nearing its completion for those who enjoy listening to big-band music and dancing with fellow LIR travelers.

Sunday morning we begin our return trip to Jefferson City. The Reverend Dr. Stephen Buchholz, guest escort on the trip, will lead us in a scripture reading upon our departure from Clarinda. We will enjoy an early lunch at Cracker Barrel in Lee's Summit before arriving back in Jefferson City.

All admissions, gratuities, lunches, and dinners Friday and Saturday are included in the trip cost. Arrangements may be made at each of the restaurants to accommodate special dietary needs. Lunch Sunday is on your own. Breakfasts Saturday and Sunday are complimentary at the hotel.

#### **Going High in St. Louis** Tuesday-Wednesday, June 18-19, 2019

Don't miss out on **Going High in St. Louis**. As we travel through the city, look up and watch for the tall, concrete silos that mark the Ikea store. That's right, ladies and gents, our first stop will be two hours of shopping at Ikea. We will see how ingenious the Swedes are at creating storage and the efficient use of space. (Don't worry guys, your time is coming.)

After browsing Ikea, you will be looking for a place to rest, relax, and rejuvenate for the afternoon. We will take a short drive to The Hill for an Italian Buffet at Favazza's, a family-owned restaurant (included).

The afternoon events start at the St. Louis Central Library. The library began in 1865 as a subscription library in the public-school library system and evolved into the St. Louis Public Library that worked in tandem with the public education system and offered citizens an opportunity for self-improvement and culture. The current library, built in 1912, is located in the former St. Louis Exposition and Music Hall. In 2012, an extensive \$70 million award-winning renovation was completed and showcases a masterful blend of classical and modern architectural styles.

Upon leaving the library, we will visit the Campbell House Museum. This is the last remaining building from the lost neighborhood, Lucas Place. Built in 1851, it was home to Robert & Virginia Campbell and their 13 children until 1938. This building is not handicapped accessible. Guests with limited mobility will be able to visit the first floor, carriage house, and gardens while others also visit the second and third floors.

Day one will end early at the Drury Inn at the Arch. Dinner will be at the complimentary Kickback Reception in the hotel or on your own in either of the two restaurants in the hotel or others located near the hotel. You will be within several blocks of restaurants near the Gateway Arch or with a slightly longer walk to the St. Louis Cardinals' Ball Park Village. Note: The Cardinals play the Miami Marlins at 7:15 p.m. if you want to arrange for your own tickets.

Day 2 begins with a complimentary breakfast at the hotel. Put on your walking shoes as there will be **considerable** walking involved in the Arch tour. You will have approximately six hours to explore on

your own at the newly renovated Gateway Arch Museum and grounds. The Arch museum is free. Your trip registration includes the tram ride to the top of the Arch, the documentary film *Monument to the Dream*, and a one-hour riverboat cruise. The riverboat cruise will have a set time, but the remainder of our six-hour visit is open for you to explore the Arch grounds at your own pace.

You may also visit the Old Cathedral on the Arch grounds although it is not part of the National Park Service. The fee for the self-guided tour is \$2 and is your responsibility. You may also walk about two blocks to the Old Courthouse. Lunch will be on your own on Day 2. At a specified time and place, we will all gather for the ride home, where you can nap or visit with our fellow travelers.

Your registration fee includes lunch on The Hill and dinner at the Kickback Reception at the Drury on day one. On the second day, your breakfast is complimentary at the hotel, and lunch is on your own. We should be back in Jefferson City by dinner. Meal and venue tips, including the coach driver's tip, are covered in your registration fee.

### "Liberté, Egalité, Fraternité" de St. Louis Saturday-Sunday, July 13 & 14, 2019

"Bonjour, mes amis!" Join us in an exploration of French Heritage in St. Louis. What better time to look at all things French than Bastille Day! We will start by tracing early French settlements in Cahokia, IL. We will explore the current remaining French areas and place names in St. Louis, including a visit to Soulard Market (the oldest operating farmers market in the U.S.), the French history area of the newly renovated museum at the Arch, a walking/bus tour of the areas of St. Louis now known as Soulard Lafayette Square and Park.

We will celebrate French culinary contributions with a lunch at a French restaurant and a French cooking demonstration and dinner at the Kitchen Conservatory. And, of course, do not expect a mint on your pillow at the Drury Inn—Westport when you can have a French confection.

Day two will culminate our trip with a visit and tour of the historic Chattion-Demenil Mansion. There we will witness dancing, re-enactments of the musketeers, Marie Antoinette, Louis the XVI, and the storming of the Bastille with the king and queen losing their heads in a guillotine. ### Washington: Small Town Missouri

Wednesday, July 24, 2019

The German populace for which Washington is known began with the arrival of twelve Catholic families in the fall of 1833. This group and later other German immigrants wrote glowing reviews of the lush, green, rolling hills and the river valley that reminded them of their homeland. A natural river landing made this an ideal place to begin a settlement, and on May 29, 1839, about (Continued in next column) 50 acres of this beautiful area was officially established as the City of Washington.

Many of Washington's historic structures remain today, which we will see and hear about via a step-on guide. Stops include the <u>Gary Lucy Gallery</u> (with an opportunity to hear from the artist Gary Lucy), the famous Missouri Meerschaum Corn Cob Pipe Factory Museum, the Iron Spike Model Train Museum, St. Francis Borgia Church, and the Historical Society Museum.
