Southeast Missouri in the Fall

Missouri Springs and Historic Arcadia Valley September 24-25, 2013

You won't want to miss this tour of many beautiful Springs in Missouri and the historical Arcadia Valley. Do register early for this two day trip highlighting our beautiful state.

We embark early morning for our adventures to assure ample time to visit all locations on this zealous itinerary. Day I stops include 1st, <u>Meramec</u> <u>Spring Park</u> where the park naturalist will present an overview and we will enjoy the Visitors Center exhibits before viewing the Spring. Stop #2 is <u>Round Spring</u>, located near Eminence, one of the first Missouri State Parks. We will enjoy a box lunch at the pavilion before motoring to <u>Alley</u> <u>Springs</u>, our 3rd stop. Here, in addition to the Springs, we will have a guided tour of <u>Allev Mill</u> by National Park Service staff. Stop #4 is <u>Big</u> <u>Springs</u>. Missouri's largest Spring and the largest fresh water Spring in the United States. This is our last scheduled tour stop for the day before arriving at Hampton Inn, Farmington. After 'check-in', a group buffet dinner is scheduled at <u>Roseners</u> in Farmington.

Day II (Wednesday) begins with a continental breakfast at the hotel followed by our 1st stop at <u>Missouri Mines State Historic Site</u>. Following a brief orientation we view the early 1900's lead mining equipment and tour the mineral museum located at the Site. Stop #2 is <u>Elephant Rocks State</u> <u>Park</u> where we will have the opportunity to walk the mile long Braille Trail and/or climb the rocks, all optional of course. Stop #3 will be a buffet lunch in Ironton at "<u>Thee Abbey Kitchen</u>" located on the former site of the Ursuline Academy. A short tour of the beautiful chapel is included at this stop.

Following lunch we stop briefly at <u>Taum Sauk Mountain State Park</u> (highest point in Missouri) and then motor to <u>Johnson's Shut-Ins State</u> <u>Park</u>. After visiting this state landmark, we are homeward bound with a rest break at a fast food restaurant along the way.

This trip involves lots of walking; comfortable walking shoes are recommended. Many resting places are available in the parks to relax and enjoy the scenery should this be your choice. Also, bring rain gear as we plan to go rain or shine.

The area features some wonderful examples of German style homes and buildings. Dr. Schroeder is the authority on this area of Jefferson City.

Week Two: It is a tour of the old State Penitentiary with Mark Scheiber as our tour guide. Mark is the foremost authority on the history of MSP and will delight all who come to learn of its story and to see first-hand what it looked like "behind the walls!" Gather at the front gate of the old Penitentiary across the street from the new Federal Court House on Lafayette Street.

Week Three: This is a tour of the River Bluffs Collection located at the old women's prison site, the former state surplus building. This building

now houses all the historic pieces that go into the state Capitol Museum. As pieces are rotated in and out they are housed here. This tour will be led by the curators of the River Bluffs Collection. It is a fascinating place with many artifacts of treasured history. Gather at River Bluffs Collection (former State Surplus Property Building), 117 North Riverside Drive. Parking lot in front of building.

Week Four: This will be our final session as we walk down East Capitol Avenue with Dr. Gary Kremer. This was the premier area of affluence in early Jefferson City history. Learn more about the homes, buildings, and people of this historic area of our city. Dr. Kremer is a leading authority on this history and area of Jefferson City. Gathering place will be at the Lewis and Clark statues on East Capital between the State Capitol building and Lohman's Landing.
