Urgent Matter: Request for Board of Curators' Attention Regarding Recent Events

Dear Members of the Board of Curators,

I trust this letter finds you well. It is with a heavy heart and a deep sense of responsibility that I, on behalf of the Student Government Association, bring forth a matter of utmost gravity that demands your immediate attention and consideration.

In light of the recent tragic events surrounding Dr. Candia-Bailey, our purpose in addressing this esteemed Board is to discuss the disconcerting circumstances that have arisen involving President Mosley, Jermey Folk, April Roberson, and Dr. Pasley. The incident has given rise to a multitude of questions within the student body, prompting our earnest need to express our concerns in a much needed meeting.

The glaring absence of any acknowledgment or discussion regarding the untimely passing of the Student Affairs Vice President has raised significant apprehension among the student community. We are troubled by the omission of such an important matter from the agenda of the recent open session meeting, and it is with a profound sense of duty that we propose the inclusion of the student body on the agenda for the upcoming Board of Curators meeting. We have a direct narrative that we will address and bring about conversations within this meeting.

Furthermore, we wish to convey our profound lack of confidence in the current leadership, comprising the President, Chief of Staff, President of the Board of Curators, and Director of Human Resources. This lack of confidence stems from what we perceive as negligence and a notable absence of accountability in addressing critical issues that directly impact the university community.

As representatives of the student body, we firmly believe that it is imperative for the Board of Curators to be fully transparent and open in matters that have far-reaching consequences for the university's environment and the well-being of its members. The neglect and lack of accountability demonstrated in addressing important matters, such as the passing of our Student Affairs Vice President, signal broader issues that necessitate immediate attention and resolution.

We respectfully urge the Board of Curators to address these concerns promptly and take decisive action to ensure transparency, accountability, and effective leadership within the university. Open and honest communication, coupled with a genuine commitment to addressing the needs and concerns of the university community, is crucial for fostering a positive and supportive environment for all.

We sincerely appreciate your unwavering dedication to the welfare of our university and the crucial role you play in its governance. We look forward to a constructive dialogue aimed at

addressing these critical issues and fostering a campus environment that reflects the values of transparency between all channels within our institution, accountability, and effective leadership.

#### **BOC** Bullets on Mental Health Care

- The Lincoln University Board of Curators and the University as a whole are committed to promoting the overall wellness of our students, faculty and staff.
- The University regularly has licensed counselors on-hand through Thompkins Health Center from 9 a.m. to 5 p.m. Monday through Friday. Appointments are available through the health center webpage, by emailing the center or calling.
- The University is currently offering additional counseling hours on campus through Compass Health. Currently the hours are Mondays from 11 a.m. to 1 p.m. and Thursdays, from 2 p.m. to 5 p.m. The usage of the service will be reviewed during the week of February 12 to determine how best to meet the current and future needs for additional counselors on campus.
- Any member of the University family is encouraged to utilize the 988 Suicide and Crisis
  hotline for confidential support for anyone. This number accepts text and calls and has been
  communicated through campus email and is also printed on the back of all University-issued
  employee and student ID cards.
- The University has also partnered with several local and national organizations to serve more specific populations such as the Black Emotional + Mental Health Collective, the Steve Fund Text line (for young people of color), the Trevor Project Crisis and Text lines (for LGBTQ individuals), and the Trans Lifeline.
- The University has developed the "Becoming a Healthier LU: Healthy Mind, Body and Spirit" initiative, which will aid in focusing on the whole self. This initiative will also help guide in identifying additional resources for those who need it, including those related to promoting mental wellness.
- The University will continue to expand our partnerships to ensure the providers and the services available are as diverse as our Blue Tiger Family.
