6. B. Update to the University Property Control Policy (Enclosure 8):

6. C. Fiscal Year 2026 General and Auxiliary Operating Budgets (Enclosure 98):

Kathy Mangels, Interim Vice President for Administration and Finance, reviewed the attached Fiscal Year 2026 General and Auxiliary Operating Budgets. The total General Fund Budget is \$43,196,623, and the Auxiliary Fund Budget is \$6,973,471. The FY26 budget includes an additional \$2.3 million to complete implementation of the salary study for faculty and staff, with individual adjustments capped at 11% for faculty, 5.5% for staff, or a 2.5% COLA increase for employees not affected by the salary equity study. Curator Popp moved for approval of the FY26 budgets as presented. Curator Cade seconded the motion. Motion carried.

The Chief Operating Officer, Provost, Vice Presidents, and the Athletic Director gave brief reports from their respective areas. The reports were for the Board's information and required no action.
