Lincoln University (LU) provides farmers with education and technical support on crop production and protection. Farmers are also made aware of USDA programs that are available to them to grow their operations, improve their practices and increase their income. Lincoln University also helps farmers apply for these programs.

Farm Service Agency (FSA) helps farmers by ensuring a strong safety net through loan programs and insurances. FSA programs include Specialty Crops Insurance, Operating Loans, microloans, Farm Ownership Loans, Guaranteed Loans, Youth Loans, Emergency Farm Loans, and Native American Tribal Loans.

Natural Resources Conservation Service (NRCS) helps farmers develop conservation solutions to protect natural resources. NRCS also aids farmers in managing financial risk through diversification, marketing and/or conservation practices of natural resources. It provides farmers with financial and technical assistance to address natural resource concerns. The agency delivers environmental benefits to help farmers enhance their working farms through conservation easements.

Rural Development (RD) provides funding to assist in the development of essential facilities in rural communities afflicted by extreme unemployment and severe economic depression. Funds may be used to construct, enlarge or improve community facilities for public safety and public service. Local food systems may apply for Rural Development funds. They include community gardens, food pantries, community kitchens, food banks, food hubs and greenhouses. Farmers may benefit from these services with conditions.

Missouri Soil and Water Conservation Districts (MO SWCD) carry out Missouri’s soil and water conservation programs. The districts provide information and education, financial incentives and technical support to help farmers reduce soil erosion and protect water resources.

North Central Region Food Safety Modernization Act Training, Extension, and Technical Assistance (NCR FSMA TEATA) provides farmers with information on whether or not they are to comply with Produce Safety Rule (PSR). The center also provides farmers with information and training on how to comply with the rule and addresses farmers’ questions and concerns regarding food safety.

Missouri Sustainable Agriculture Research and Education (MO-SARE) provides farmers with education on sustainable agricultural practices. It also provides farmers with information and training on how to access funding from Missouri SARE to implement innovative sustainable agricultural practices through farmer/rancher grants or partnership grants.
